

Ny-Ålesund Research Station Guide for media visits

Summary

- If you are planning to visit Ny-Ålesund Research Station, you must submit a description of what you intend to do, when you wish to visit, etc. to the relevant institution with national coordination responsibilities for Ny-Ålesund Research Station.
- Booking of transportation and/or accommodation should be initiated <u>only</u> when your plan has been assessed and approved by the relevant institution with national coordination responsibilities.
- Booking requests should be <u>sent from the relevant institution hosting the media visit</u> to <u>booking@kingsbay.no</u>, with a copy to <u>visit.nya@npolar.no</u>

General information

Ny-Ålesund Research Station at 79° north is a Norwegian research station hosting national and international natural science research projects and environmental monitoring programmes run by institutions from more than 20 countries. The research station serves both as an observatory, as a laboratory, and as a field base for a range of Arctic natural sciences research projects, spanning from marine geology and oceanography, via terrestrial ecology and glaciology all the way to upper atmospheric research.

Ny-Ålesund's history as a coal mining community and as a starting point for numerous Arctic expeditions is unique and laid the foundation for the research activity that takes place here today. You can learn more about the history in the Ny-Ålesund museum, which is always open and where admission is free.

In order to preserve the near pristine environment which is critical to both the research projects and the environmental monitoring programmes, there are a number of restrictions on what other types of activities are being admitted to Ny-Ålesund. (Please see the section "Things to consider" below.)

Assessment and approval of requests for visit, and points of contact

Media organisations planning to visit Ny-Ålesund Research Station must do so as an approved guest of one of the institutions with a national coordination responsibility and a physical presence in Ny-Ålesund – see list below. This means that e.g. German media organisations should approach AWI to have their plans assessed and approved. <u>Approval</u> <u>must be gained before transportation to/from Ny-Ålesund or accommodation in Ny-Ålesund</u> <u>can be booked</u>.

Media organisations from Norway, or from any country not listed in the table above, will be hosted by <u>The Norwegian Polar Institute</u> (NPI). Request to NPI should be sent to <u>visit.nya@npolar.no</u>.

The company <u>Kings Bay</u> is responsible for logistical services, including flights, lodging, dining, running of the store and postal services. Once a visit has been approved, <u>booking requests</u> for travel to Ny-Ålesund and/or accommodation should be sent from the institution hosting <u>the visit</u> to Kings Bay <u>booking@kingsbay.no</u>. The institution hosting the visit should also send copies of the booking to both <u>visit.nya@npolar.no</u> and to the relevant media organisation when contacting Kings Bay AS.

Note that due to the heavy workload on the personnel and scientists working in Ny-Ålesund, media visitors cannot expect that all scientists or local staff will be available for interviews. To ensure that visits are as productive and efficient as possible, it is important to start the planning process well in advance of the actual visit.

Information regarding expenses

When visiting Ny-Ålesund you should plan for the following expenses:

- <u>Transportation</u>. There are regular flights between Ny-Ålesund and Longyearbyen two days a week. Groups of six or more passengers are required to book charter flight.
- <u>Room and board</u>. Prices vary depending on the lodging which ranges from hotel rooms with private bathrooms to more basic rooms with shared bathrooms.
- <u>Other expenses</u> could be for; Safety course, extra meals, or rental of weapons, snowmobiles, cars, meeting rooms or other equipment as required.
- <u>Payment</u> is by debit or credit card. Guests pay when checking out in the reception before leaving Ny-Ålesund. (Please note that for technical reasons, American Express cannot be used.)

Things to consider

- The Norwegian Mapping Authority runs measurements in Ny-Ålesund that are critical to reliable use of GPS systems and to a host of other applications. NMA's measurements are severely compromised by the use of any equipment transmitting in the 2-32 GHz frequency band (this includes Wi-Fi and Bluetooth (BT)), and the use of such equipment is therefore in general not allowed in Ny-Ålesund, or in an area covered by a 20 km radius out from Ny-Ålesund. In this area, you must therefore disable Wi-Fi and BT on all your devices (mobile phone, camera, smart watch etc., etc.).
- The use of any equipment operating in the 2-32 GHz frequency band requires a permission from The Norwegian Communications Authority (<u>Nkom</u>). - The use of UAVs requires a special permission. Please see <u>here</u> and/or contact NPI's research coordinator <u>research.nya@npolar.no</u> for additional information on the use of UAVs.
- It is illegal to enter any of the research installation areas in and around town for unauthorized personnel. Most of these areas are <u>not</u> fenced off but are shown on maps available in town and posted on the information board. (Also available on the last pages of this document.)
- When in Ny-Ålesund, only walk on roads and boardwalks. Respect the regulations for bird sanctuaries in the period from 15th of May to 15th of August. They are marked on maps of Ny-Ålesund, and there are signs placed on critical spots around town.
- **Wild animals** may appear friendly and curious in Svalbard, but you are not allowed to approach, attract or feed any wildlife. Rabies is present in Svalbard from time to time.
- To travel outside the settlement, you must carry a rifle or be escorted. Rifles can be rented from Kings Bay (against a fee), provided you have a valid weapons permit, and have completed a safety course. Safety courses are arranged and booked via Kings Bay.
- You must always get permission before filming or taking pictures of people. Filming and taking pictures in the dining hall is permitted only with the explicit approval of Kings Bay.
 You are not allowed to take pictures/video in social settings after 22:00, and never in the bar.
- Remember, we are in the Arctic, and the weather can change quickly. Therefore, flights to and from Ny-Ålesund may be cancelled or postponed on short notice. It is therefore advisable to **plan for delays** when travelling to and from Ny-Ålesund. Kings Bay is not responsible for extra costs that accrue due to delays and cancellations. You are strongly encouraged to have a valid travel insurance. Passengers on the flights to/from Ny-Ålesund can only bring 20 kg luggage (incl. hand luggage).




Required information when requesting a visit

The following information must be provided by the media organisation or journalist that wants to visit Ny-Ålesund Research Station. This information should be provided through a separate form *Request for visit by media actors* which has to be sent to the relevant research institution with national coordination responsibilities for assessment. The different institutions should keep NPI informed about requests and the planning process. NPI will keep a complete list of media visits to Ny-Ålesund Research Station. The following information should be given through the *Request for visit by media actors* form.

- Name of media organisation
- Contact person Name, e-mail and cell phone number
- Institution in Ny-Ålesund that has assessed the request and that will be your host
- Purpose of the visit and topics of particular interest
- Time of planned visit to Ny-Ålesund Arrival and departure date & time
- Mode of transportation Regular flight (max 5 people) / charter flight / boat
- Total number of people in the group
- Names etc. of members of the group Full name, gender, title and phone number
- Lodging request Lodging through Kings Bay (information here), own institution, etc.
- NB! Please specify any allergies or other dietary requirements
- Additional requests Meeting room, private dinner, etc.
- NB! Plan for work to be done in Ny-Ålesund
- NB! Invoice information E.g., contact person, reference number, ...
